## **Haulage Contractor Undertaking:**

### **The undersigned Haulage Contractor**

is authorised to:

- provide HORIBA Jobin Yvon SAS with full information relative to the procedure for activities performed on the operating site

and will hereby ensure that:

- all documents that HORIBA Jobin Yvon is entitled to request from vehicle drivers are available and will be provided, pursuant to the Labour Code and regulations in force, before any loading or unloading operations are performed.
- the equipment and vehicles used during loading and unloading operations are compliant and have been correctly maintained.
- vehicle drivers comply with all the general safety conditions relating to loading and unloading as described in this safety agreement.
- vehicle drivers comply with the instructions for driving around HORIBA Jobin Yvon sites as described in this safety agreement.
- all haulage contractor drivers performing loading or unloading operations during the contractual period authorised by this safety agreement have been trained and are competent in the execution of their work, in line with the latest practices in force for loading and unloading operations.
- all haulage contractor drivers performing loading or unloading operations during the contractual period authorised by this safety agreement are legally employed personnel, pursuant to the provisions of Articles L.143-3, L.143-5 and L.620-3 of the Labour Code
- drivers comply with all prevailing regulations governing road haulage when carrying HORIBA Jobin Yvon SAS goods, both on HORIBA Jobin Yvon sites and the national and international road network.

Should subcontractors be used, the Haulage Contractor will ensure that:

- all the above-mentioned undertakings are complied with by haulage contractors with which subcontractor contracts have been established.

In the event of repeated and/or serious breaches of the above-mentioned undertakings, HORIBA Jobin Yvon SAS will be entitled to terminate work agreements between HORIBA Jobin Yvon SAS and the haulage contractor without any specific formalities or compensation.
